The Acai berry seed takes about 80% of the total fruit and the seed can be used in certain animal feeds after grinding. Two predominant species of acai exist: Euterpe Oleracea and Euterpe Precatoria. Most of the acai readily available on the market is produced from oleracea variety. Our acai belongs to a more unique botanical variety - Euterpe Precatoria which is high in antioxidants. Organic Acai powder is certified organic by the Soil Association under the code GB-ORG-05.
